**PARKING PERMITS ARE \$ \_\_\_\_\_ (Cash/Check/Money Order) A Valid Texas Drivers License/Permit, Proof of insurance and a license plate tag number is required to purchase a parking permit.**

The parking permit is only valid for the 2008-2009 school year for the vehicle described above. If I purchase another vehicle I may transfer my parking permit but I must inform Mr. Ephraim (Austin ISD Security Officer) of the new vehicle information. **If my parking permit is lost for ANY reason I will be required to purchase at full price throughout the school year if I want to continue to park in the student lot.** One permit **IS NOT authorized for multiple vehicles.** I must purchase a permit for each vehicle I will operate. Violations of the school parking policies will to a revocation of privileges and possible towing of the offending vehicle. An additional \$25.00 littering fee will be charged to students found littering in the parking lot.

I understand 9<sup>th</sup> –11<sup>th</sup> graders do not have the authority to leave campus during school hours. **Daytime city curfew ordinance Monday-Friday 9:00 am – 2:30 pm. The curfew ordinance applies to minor between the age of 10-16 years of age. Any juvenile cited for a curfew violation will be issued a Class C misdemeanor.** I also understand **ONLY SENIORS over 17 years of age** are allowed off campus during the lunch period. If a senior transports a non-senior off campus during school hours, the senior's parking privileges will be revoked to park on the campus of LBJ/LASA High School for the 2008-2009 school year.

LBJ/LASA High School is a closed campus. Once a student enters the campus he/she may not leave without a permit to leave or until the end of their school day. Students who leave the school campus without a permit to will have their parking privileges revoked.

Parking spaces designated for **faculty and visitor parking** are not to be used by the students. **All student vehicles found parked in any of these areas, will (1st time) have a sticker notice placed on the window. (2<sup>nd</sup> time) an orange boot placed on the front of the vehicle (3<sup>rd</sup> time) The vehicle will be towed. NO DOUBLE PARKING ALLOWED.** NO PARKING IS ALLOWED BEHIND THE SCHOOL GYM (FACULTY) PARKING LOT, UNTIL AFTER SCHOOL 3:40 PM. THERE ARE NO RESERVED PARKING SPACES FOR STUDENTS IN THE STUDENT PARKING LOT. All vehicles must have valid inspection and registration. Upon being notified of the infraction, the vehicle may not be parked on campus until Mr. Ephriam (AISD Security Monitor) has verified the information.
